APPENDIX 2 - ARCHERY CANADA CODE OF CONDUCT AND ETHICS

The **old version** of the Archery Canada Code of Conduct and Ethics was **totally replaced** with the January 2023 version of the Archery Canada Code of Conduct and Ethics.

Book 4

AC 23.7.6.1. (2022 ver.)

An arrow shall not be considered to have been shot if:

- The athlete can touch it with his bow without moving his feet from their position, and provided the arrow has not rebounded;
- The target falls over. The Judges shall take whatever measures they deem necessary, and permit time for shooting the relevant;
- number of arrows;

 - Note: A pass-through is defined as an arrow passing completely through a target, with target material 360 degrees around the arrow, leaving both an entrance and exit hole.

AC 23.7.6.1. (2023 ver.)

- The arrow is a witnessed pass-through or bounce-out and the majority of the group cannot agree on the score before the archers advance to the target:
 - Note: A pass-through is defined as an arrow passing completely through a target, with target material 360 degrees around the arrow, leaving both an entrance and exit hole.
- (Indoor 3D only) - Two arrows that, in the opinion of a Judge, have collided, and both arrows have missed their intended targets.

AC 24.2.3 (2022 ver.)

Archers shooting from the same position are to rotate shooting order from target to target.

AC 24.2.4 (2023 ver.)

Archers shooting from the same position are to rotate shooting order from target to target.

Shooting groups shall be “busted.” A group with 3 or 4 friends or family members, plus an outside person, is considered “busted,” provided that the outside person is one of the scorekeepers for the group.

AC 24.2.5 (2023 ver.)

Shooting groups shall be “busted.” A group with 3 or 4 friends or family members, plus an outside person, is considered “busted,” provided that the outside person is one of the scorekeepers for the group.

When practically required, categories may be combined in a shooting group.
