Chris Lindsay, Own the Podium (OTP), provided a verbal report to the membership during the High Performance Committee Report outlining OTP's satisfaction with the remarkable change that has occurred within Archery Canada's high performance system in the last two years. Other highlights include:

- International partnerships with Netherlands, USA, and Germany are providing extraordinary training and cooperative competition opportunities
- Identification of the next national team is being done in a way that assesses competition results and athlete characteristics all in a systematic process
- TOPS program is identifying talent, improving skills, and supporting local coaching
- Moving to a full-time NT coach is a major and necessary step
- Lessons learned from the Olympic program need to be shared by the NT and replicated by the Paralympic and compound disciplines
- \$150,000 in funding to come from OTP/Sport Canada for Next Gen

2017 3D, FIELD & TARGET CHAMPIONSHIPS (QC)

2018 3D INDOOR CANADIAN CHAMPIONSHIP

The 3D Committee reported that this event may occur in Brandon, Manitoba but is still to be confirmed.

2018 3D, FIELD & TARGET CANADIAN CHAMPIONSHIPS (NS)

The Archery Association of Nova Scotia (AANS) reported that these championships will all be held in the same town - Truro, NS, located 30 min from the Halifax International Airport. AANS has used their time at

the 2017 3D, Field & Target Championships as observation and learning opportunities as they ramp up preparations to act as next year's hosts.

2019 3D, FIELD & TARGET CANADIAN CHAMPIONSHIP (SK)

The Saskatchewan Archery Association (SAA) reported that the Timberland Bowbenders will host all of the 2019 Championships. Currently new configurations for the field course and a new 3D course are being worked on as other preparations are underway to host these events.

12. NEW BUSINESS

12.1 GOODS & WELFARE

- Membership Agreements: J. Brehaut (AB) asked the Board for clarification regarding the FTAQ
 member operating agreement and outlined the impact of an unsigned agreement on the rest of
 the Archery Canada membership and registrants. The Board outlined that following a meeting
 with the FTAQ this week, a response will be provided by FTAQ by end of August regarding the
 signing of this agreement.
- French Translations: M. Charron (QC) expressed concerns regarding the lack of French
 available on the Archery Canada website, and in coaching and judging books. The Board has
 indicated that Archery Canada has come a long way in terms of providing French translation of
 material, has passed a Sport Canada bilingualism audit and has made recently increased to the
 translation budget in the hopes of addressing any disparity between English and French content.
